- 5. The purpose of this amendment is to dispose of any assessment on lot 14 in that only one family will be occupying Lot 13and a portion of Lot 14 and only one family will be occupying Lot 15 and a portion of Lot 14.

We hereby agree that said annual assessment (and any special assessments) shall be apportioned between the owners of Lots 1 through 13 and Lots 15 through 25 (24 lot owners).
